

Studio 9 Dance Academy

Phased Reopening Plan

Studio 9 Dance Academy will implement a phased reopening plan for the studio. We are hopeful to continue progressing forward throughout the summer months, and prepared for all scenarios should we need to transition to/from any phases at any point. The following policies and guidelines are based on a hybrid of CDC, State of Colorado and Douglas County COVID-19 suggested guidelines.

Phase 1

- **Businesses limited to 10 people or less**
- Dancers are permitted to schedule private lessons, or group private lessons (2-5 dancers) directly through instructor
- All guidelines below must be strictly followed for private lessons
- All regularly scheduled classes will be held via Zoom
- Tuition will be based on our normal sliding scale (see www.s9dance.com/tuition) & an additional 20% Zoom discount will be added starting June 1
- Camps & Intensives will be held in a modified format on Zoom

Phase 2

- **Businesses limited to 50 people or less**
- Dancers will be permitted to take group classes in building, limited class sizes (8-12 dancers max, based on room sqft)
- Tuition will be based on a per class rate:
 - \$48/month (All 45 minute classes)
 - \$96/month (All 1.5 hr classes)
- Drop in and trial classes are not permitted

Phase 3

- **Businesses open as normal with Sanitation Standards**
- Class and Camp structure return to normal
- Tuition will be based on normal sliding scale (See www.s9dance.com/tuition)
- Drop in and trial classes are permitted

General Studio Guidelines for Phases 1 & 2

- Only Dancers, Teachers & Staff will be permitted inside the studio
- Temperatures will be taken at the door
- Staff will ask if you have any symptoms prior to entry into the studio
- Hands must be washed & sanitized upon entry into the studio, between all classes and after using the restroom
- Social Distancing applies while inside the studio
- No public water fountain will be available
- All cubbies, barres & floor will be wiped down
- Toilet seat sanitation covers must be used inside restrooms
- Masks should not be worn while dancing/exercising, but are encouraged while physical activity is not taking place

Guidelines for Dancers/Parents in Phases 1 & 2

- Dancers may arrive 5 minutes prior to the start of class. Please remain in your car until that time
- Dancers will be dropped off at the front of the studio and will enter one at a time through ENTRANCE labeled door
- Please ensure dancers are ready prior to entering the studio (having own water bottle, extra hair ties, already in dance clothes)
- Parent viewing area/lobby will be closed off
- No congregating will be allowed in the parking lot
- No cash payments will be accepted. All payments will be through your parent portal/jackrabbit account
- Dancers must wash hands/use hand sanitizing stations between classes
- Dancers 6 and younger will be greeted @ entrance by staff & walked outside after class
 - Parents must wear masks and practice social distancing while picking up/dropping off child
- Dancers must exit studio through EXIT labeled door one at a time
